

Prior to holding the Regius Chair in Humanity at the University of Aberdeen, Fr John Behr spent twenty-five years teaching at St Vladimir's Orthodox Theological Seminary in New York, where he also served as Dean for a decade. He has taught at other schools in the US, such as Harvard Divinity and Fordham University, and as the Metropolitan Kallistos Chair of Orthodox Theology at the Vrije Universiteit of Amsterdam.



Dr Mario Baghos is Lecturer in Theology (Patristics) and Church History. His research interests include patristic eschatology, representations of Orthodox Christian saints, and the role of religion (specifically Orthodox Christianity) in cities via art and architecture. He is also the Chief Publishing Officer of St Andrew's Orthodox Press.

Accreditation

St Andrew's Greek Orthodox Theological College is accredited through the Sydney College of Divinity (SCD), a Higher Education Provider owned by an ecumenical consortium of private colleges, which are its Member Institutions.

Unit Objective

This graduate unit (AQF Level 8) engages the main themes and characteristics of Patristic tradition, which it examines within their historical context and from a comparative perspective. It assists students to appreciate the significance of various trends in traditional theology and spirituality for the general Christian experience.

Learning Outcomes

- 1. Appreciate the historical and ecclesial contexts of various trends in early patristic tradition
- 2. Display an awareness of the main themes pertaining to early patristic tradition
- 3. Utilise primary and secondary sources in the analysis of patristic themes
- Analyse themes pertaining to the early patristic tradition within their immediate and distant literary and historical contexts
- 5. Assess the relevance of patristic tradition to contemporary scholarship and the Christian experience

Enrolment Options

This unit will be delivered by weekly Thursday lectures via Zoom, 5:00pm start time (Sydney time, AEST) until 8:00pm, beginning July 29.
