



Prior to holding the Regius Chair in Humanity at the University of Aberdeen, Fr John spent twenty-five years teaching at St Vladimir's Orthodox Theological Seminary in New York, where he also served as Dean for a decade. He has taught at other schools in the US, such as Harvard Divinity and Fordham University, and as the Metropolitan Kallistos Chair of Orthodox Theology at the Vrije Universiteit of Amsterdam. After a decade of teaching in most areas of early Christian and Byzantine studies, he began the publication of a series entitled *The Formation of Christian Theology* (*The Way to Nicaea* and *The Nicene Faith*, 2001 & 2003). In preparation for further volumes, he edited and translated the Greek, Latin, Syriac, and Armenian fragments of Diodore of Tarsus and Theodore of Mopsuestia, setting them in their historical and theological context. However, realizing that to go further into the sixth century also meant returning to, and reconsidering, Origen, he prepared a new edition and translation of his work *On First Principles* together with an extensive introduction (2017). Having also completed a full study of Irenaeus a few years earlier (*Irenaeus of Lyons: Identifying Christianity*, 2013), he was drawn yet further back, to the Gospel of John (*John the Theologian and his Paschal Gospel*, 2019), putting his findings from decades of research on the early Christian writers, as the earliest readers of John, into dialogue with contemporary readers of John, both scriptural scholars and also, returning to his earlier studies, the French phenomenologist Michel Henry, as an act of constructive theology.

#### Accreditation

St Andrew's Greek Orthodox Theological College is accredited through the Sydney College of Divinity (SCD), a Higher Education Provider owned by an ecumenical consortium of private colleges, which are its Member Institutions.

The Sydney College of Divinity is listed on the National Register of Higher Education Providers as a Higher Education Provider with Self-Accrediting Authority. It is approved by the Commonwealth for FEE-HELP to eligible students.

St Andrew's Greek Orthodox Theological College offers undergraduate and postgraduate units of study towards SCD courses of study.

#### Cross-Institutional Study



## ST MAXIMUS THE CONFESSOR

## Unit Objective

This postgraduate unit (AQF Level 9) advances the study of the patristic phenomenon by focusing on the crucial contributions of St Maximus the Confessor. It enables students to appreciate these contributions within a complex framework, theological, spiritual, literary and historical.

## Learning Outcomes

1. Appraise the personality and the contributions of St Maximus.
2. Display a profound knowledge of a select representation of St Maximus' writings.
3. Evaluate the contributions of St Maximus within the broader patristic tradition.
4. Critically analyse the selected writings of St Maximus within the framework of contemporary Maximian scholarship.
5. Assess the relevance of St Maximus to contemporary Christian theology and experience.

## Enrolment Options

This unit will be delivered by weekly Wednesday lectures via Zoom, 5:00pm start time (Sydney time, AEST) until around 6:30pm/7:00pm, beginning July 28.

Students are strongly encouraged to login and participate in real time (synchronous learning). But a student may also enroll and access the video recordings of the weekly Zoom classes and review these in their own time (asynchronous learning).

## Content

1. Treading the way between the Greek and Syriac biographies of St Maximus
2. The historical, theological and cultural context of St Maximus
3. Main contributions to theology, spirituality and exegesis
4. The traditional reception of St Maximus and the perennial significance of his contributions
5. *Status quaestionis* in contemporary Maximian scholarship
