# **Cross-Institutional Study**



## **Unit Objective**

This postgraduate unit (AQF Level 9) advances the study of the patristic phenomenon by focusing on the crucial contributions of St Maximus the Confessor. It enables students to appreciate these contributions within a complex framework, theological, spiritual, literary, and historical.

# **Learning Outcomes**

- Appraise the historical, ecclesial, and cultural contexts of St Maximus the Confessor.
- Reflect critically on the ways in which St Maximus assimilated and transformed the earlier Christian tradition
- Demonstrate comprehensive understanding of the theological, exegetical, and spiritual legacy of St Maximus
- Analyse the selected writings of St Maximus from the viewpoint of their theological, exegetical, and spiritual significance
- 5. Contextualise and critique recent scholarship.

#### **Prerequisite Unit**

T7171 Early Church Fathers or T8171 Church Fathers: An Introduction (or equivalent foundational knowledge in patristic studies)

#### **Enrolment Requirement**

This unit will comprise eight (8) lecture sessions delivered by three eminent scholars in the field of St Maximus studies in a "multi-modal" format which includes:

- three (3) periodic Zoom lectures, plus
- five (5) intensive sessions on campus, plus
- symposium attendance in Sydney (2 & 3 September 2022)

Students are required to participate in all aspects of this course unit as outlined in the "Teaching Schedule."
