# **Curriculum Objectives**

This course unit enables students to study the two-volume work Luke-Acts which encompasses a Gospel and an early Christian theological history. It builds upon at least one previous unit on the New Testament and can advance Biblical Studies for students in AQF Level 9 programs.

# **Learning Outcomes & Threshold Concepts**

At the end of this course unit, students will be able to:

- 1. account at an advanced level for the complex historical, religious, and social background of Luke-Acts
- 2. explain the various literary forms used in the construction of Luke-Acts
- 3. interpret the theological themes of Luke-Acts
- 4. exegete select passages from the Gospel of Luke and Acts of the Apostles using appropriate methodologies
- 5. construct liturgies, homilies, or biblical discussion group materials on Luke-Acts

# **Learning Activities**

Online, with live optional class presentation, Thursdays, 9.30am – 11.30am, available for those who can attend.

- Lecture, presenting the content of the week's topic
- Associated discussion and note-taking
- Audio-visual supplements
- Workshopping of related skills including exegetical exercises

#### 1. Exegetical essay (2,400 words)

Write a critical exegetical essay on the passage Luke 5:1-16.

The exegetical essay is to follow the outline given in the lecture notes. Presentation is to be a formal essay with critical references to at least seven commentaries and/or scholarly articles, footnotes, and bibliography.

#### 2. Thematic essay (2,400 words)

The evangelist Luke portrays Christ (his Christology) as the anointed, Spirit-filled, prophetic re-interpreter of the word of God. Show how Luke develops this theme within the Gospel narrative.

# 3. Application to a pastoral issue (1,200 words)

Identify the historical and literary context of the key issue in Acts 15:1-35, describe how it is resolved, and suggest its relevance as a process for decision-making in a parish community?

#### **Extension Policy**

Students must submit all assignments by the due dates set by the lecturer and published in the course unit profiles.

#### Late Penalty

Late assignments without an approved extension will attract an automatic penalty deduction of 5% of the marks available for the item of assessment for every day (including weekends and holidays), or part thereof, beyond the date and time of submission (or any extension granted).

Assignments submitted without an approved extension beyond 10 days after the due date will receive a zero mark and NOT be annotated by the lecturer.

# **Example:**

Student submits an assignment worth 50 marks 4 days late.

Total mark available=50

Penalty: 4 days late = 5% of 50x4 = 10 mark penalty

The student's original mark is 40.

Final mark =40-10=30

#### **Grounds for Extension**

An extension of an assignment's due date may be granted on the following grounds: medical illness (certified by Medical Certificate); extreme hardship; and compassionate grounds

In such cases an extension of up to 28 days may be granted without penalty but only if requested before the assignment due date. The student should submit an "Application for Extension" including supporting documentation to the Member Institution for authorising and signing by the Lecturer / Registrar / Academic Secretary prior to the due date. The student will then be informed of the result of the request.

In extreme cases, extensions beyond 28 days may be granted. Such extensions must be applied for in writing, including supporting documentation, to the Member Institution setting out the extreme circumstances. The appropriate Member Institution's committee will consider such an unusual extension and notify the student of the outcome in writing.

If the unit assessment includes an examination and an extension is granted arrangements will be made for an alternative examination to be given to the student within the extension period.
